The game Glucozor (hereinafter referred to as the "Game") is property of the company AIR LIQUIDE SANTE INTERNATIONAL, a company under French law, registered in the Paris Trade and Companies Register (RCS) under number 552 134 728 and whose head office is located 75 Quai d'Orsay, 75007 Paris, France, who has authorized Air Liquide Healthcare Ltd. a company organized under the laws of England and Wales, registered under number 2230411 at Companies House and whose registered office is located in Station Road, Coleshill, Birmingham, B46 1JY to use the Game in compliance with the local regulations.

Terms of Use

The download of the Game is subject to the conditions of the download platform.

Installation and use of the Game are free and do not require an internet connection.

The installation and use of the game are subject to the legal provisions in force and the following general conditions of use (hereinafter referred to as the "Terms of Use").

The Game is intended for use by anyone residing in the United Kingdom with access to a mobile phone or tablet compatible with the free downloading and installation of the Game (hereinafter referred to as the "Device"). Any user of the Game is hereinafter referred to as the "Player".

The Player has to accept the Terms of Use by ticking the box (or opt-in) that is displayed when the Game is first used.

By ticking the opt-in to accept the Terms of Use, the Player fully and unreservedly accepts all the Terms of Use and acknowledges that they prevail over any other agreement with Air Liquide Healthcare in the framework of the use of the Game.

Air Liquide Healthcare reserves the right to change and/or update the Terms of Use and the Personal Data Protection and Confidentiality Policy without notice. If necessary, an updated version of the Game App will be proposed with an updated version of the Terms of Use or the Personal Data Protection and Confidentiality Policy.

Role and duties of the holders of parental responsibility

1. Purpose of the game

The challenge for the Player is to look after a diabetic dinosaur.

The educational aim is to help the Player to understand the effect of diet and physical activity on the dinosaur's blood sugar levels and learn how to manage variations in these levels. The Player has to calculate the doses of insulin to give to the dinosaur and wins a bonus in gold coins if the right dose is chosen. The bonus can then be used to buy extra items for the dinosaur.

The different Game situations apply only to the dinosaur and are not intended to replace advice given by the Player's general practitioner and the medical profession.

The parameters used to calculate the doses of insulin to be administered as part of the Game have been chosen randomly and must not be used to treat the Player under any circumstances.

Under no circumstances is this Game intended to replace the relationship between the patient and healthcare professionals and it therefore cannot replace a consultation, appointment or diagnosis given by the Player's general practitioner or be interpreted as promoting medical treatments.

2. About the game

2.1 As the Game is played off line, the Player is informed that Air Liquide Healthcare does not offer any external server backup of the Game. Nevertheless, the Game is saved on the Game Device, allowing the Player to resume the game on condition that the Player has not deleted the Game from the Device.

It is therefore not possible to resume a game started on another Device or to find a game that has been deleted.

2.2 The game begins with the hatching of a dinosaur egg and the Player having to choose a color and a name for his/her dinosaur.

The Player can also choose the dinosaur's blood sugar thresholds and his weight.

The blood sugar thresholds and weight of the dinosaur are chosen at the sole discretion of the Player and do not constitute health data and do not correspond to real data applicable to a real person in any way. Any resemblance to actual data or persons is pure coincidence and in no way shall Air Liquide Healthcare be held responsible for this.

A tutorial begins afterwards, to show the Player how to manage the dinosaur with diabetes.

The character's life is punctuated by events and the Player is informed of them by notifications during the Game and push notifications when the Player has agreed to receive push notifications.

The events consist of multiple-choice questions relating to the management of the dinosaur's diabetes.

If the Player answers the question correctly, he/she is rewarded with gold coins.

The Player earns gold coins (virtual currency of the game) as the game unfolds, allowing him/her to buy extra items to take part in different activities.

The challenges

The player is also presented with challenges allowing him/her to win gold coins. The challenges involve the Player carrying out actions him/herself or through the dinosaur.

A quiz can also be completed as an option after each challenge to win extra gold coins. After three wrong answers, the quiz is considered to be failed but the Player still earns gold coins as a consolation prize.

Under no circumstances does the Game require or offer the purchase of bonuses or accessories for a fee. In addition, no means of payment can be used to buy gold coins for the Game.

The Minigame

The aim of a round of the mini-game is to earn as many points as possible by keeping the dinosaur's blood sugar level in the optimal range of the indicator at the bottom of the screen. To do so, the Player must move the dinosaur on the screen based on the objects falling from the sky (insulin or food).

The round ends when the indicator is empty or full.

Depending on the score achieved, the Player can earn up to 5 units of Booster Time per game. Booster Time makes it possible to change the blood sugar level of the dinosaur more quickly.

3. Where the Game can be used

The Game is intended to be used by people residing in United-Kingdom. The information contained in the Game may not be appropriate outside of United-Kingdom given that regulations may be different.

4. Intellectual property

4.1 Copyright

All the software, information, trade names and trademarks accessible within the framework of the Game remain the exclusive property of Air Liquide Healthcare or any other copyright holder.
